# What we do

---

The purpose of the Bradfield Governing Board is to provide confident, strategic leadership and to create robust accountability, oversight and assurance for educational and financial performance. The Bradfield Governing Board shares with Dr Gilbert an ambition and ethos that all children and young people should achieve their full potential and thrive in school and we are infused with a passion for education and a commitment to continuous school improvement that enables the best possible outcomes. We do this by ensuring that we fulfil the three core functions of:

1. Ensuring clarity of vision, ethos and strategic direction;
2. Holding executive leaders to account for the educational performance of the organisation and its pupils, and the performance management of staff; and
3. Overseeing the financial performance of the organisation and making sure its money is well spent.

As Bradfield School is a single standalone academy converter the academy is a charitable company limited by guarantee and an exempt charity. The charitable company's Memorandum of Association is the primary governing document of the academy trust. The Governors of Bradfield School are also the directors of the charitable company for the purpose of company law and trustees for the purpose of charity law.

The company's articles of association delegate most of the decision making powers to the Governing Board which is supported by a number of committees as part of its decision making processes. The standing committees are:

- Staffing, Finance, Health & Safety and Premises Committee

The members of the committee are the Head, the Chair of Governors, the Vice chair and the chairs of the other two committees. Any governor is welcome to attend and it is often a very well attended committee. It sets the strategic direction for the governors and provides a forum for each of the committee chairs to discuss cross cutting committee issues and plans for the future

- Teaching and Learning Committee
  - Covers progress and attainment of all key stage groups as well as vulnerable groups and closing the gaps
  - Receives a termly report from a subject leader to deepen governors knowledge
  - Receives a termly report from the Inclusion Manager

- Staffing Finance Premises and Health and Safety

Covers topics such as budget planning, staffing issues and facilities management

We also have a number of other committees which only sit when required such as the Governing Body Discipline and Complaints Committees and Panels such as the Complaints Panel and Redundancy Panel.

Governors are allocated to committees based on their knowledge, skills and experience as we are aware of the need to have a full complement of relevant skills on the Board and this can vary, depending on the challenges at any one time. We actively recruit governors from our wide school community and always ensure that new governors are trained and supported so that they can become active and impacting members of the board.

We hold a minimum of three full Governing Board meetings per year (one each term) and each committee meets three times a year. However, when there are important decisions that are needed to be made we will hold more meetings as required.

The Governing Body has formally met 3 times during the academic year 2015 – '16. Attendance during the year at meetings of the Governing Body was:
